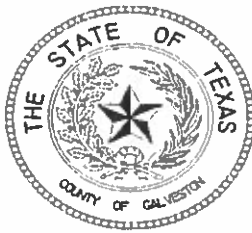

Attached to be received and filed is the Quarterly Audit Report for the Juvenile Justice Department. The audit covered the period from October 2018 through December 2018.

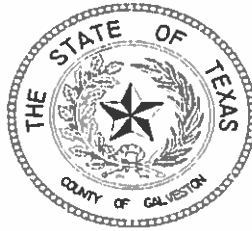

The Galveston County Auditor's Office has examined the collections of the Juvenile Justice Department for the months of October 2018 through December 2018.
